## **Excessive levels of metaldehyde already detected in water courses this autumn.**

Wet and unsettled weather in July and August encouraged a late flush of weed growth, caused problems at harvest and created ideal conditions for slugs. There is concern that any return to wet weather may cause excessive water run-off and the industry is keen to remind growers for the need for best practice use of molluscicides, particularly metaldehyde, at this time.

Dr Neal Evans, Operations Director at the VI said; “Following the long, dry spring which saw many soils develop extensive cracking, the recent wet weather in some areas of the country has resulted in run-off to water courses. We have heard reports from some water companies that they have already detected metaldehyde in raw water at levels well in excess of the 0.1 ppb limit. It is important to stress the need for careful, best practice use of pesticides and metaldehyde in particular as part of an integrated pest management approach. Careful stewardship of metaldehyde will be key as this slug pellet treatment is phased out.”

Currently, the withdrawal dates for metaldehyde are as follows:

~~31 December 2020: Deadline for the sale and distribution of metaldehyde slug pellets~~

~~31 December 2021: Deadline for the disposal, storage and use up of existing stocks~~

On 18 September 2020 Defra/HSE revoked all approvals for metaldehyde products. However, they subsequently, gave provisional approval for metaldehyde manufacturers (approval holders) and their agents to sell and distribute remaining stocks of metaldehyde until 31 March 2021. Unusually, a third part of the revocation allows non-approval holder distributors to continue to market, sell and distribute stock and for users with stored stock to store and use metaldehyde until 31 March 2022. Any use or storage from 1<sup>st</sup> April 2022 would therefore be illegal.
