

## About CSF

Catchment Sensitive Farming (CSF) is led by Natural England in partnership with Defra and the Environment Agency. It works with farmers, communities and organisations in catchments across England to improve the quality of air, water and natural flood management, through the Agricultural Transition.

Since 2006, CSF has worked with around 24,000 farms and helped farmers take more than 80,000 positive actions to reduce pollution.

"83% of farmers who had contact with their CSF Adviser agreed they were a person whose advice they could trust."

CSF and farmers have achieved reductions in agricultural pollutants - nitrogen levels are down by 4%, phosphorus levels by 8% and a 12% reduction in sediment.
